Between 31 March and 31 October 2019, how many referrals did your council receive from organisations concerning someone they believed might be homeless or may be threatened with homelessness (defined as 'within the next 56 days' from time of application)? Could you please give me the description of, and figures for the three most common types of organisations (for example: prison and youth offender institutions, secure training centres/colleges, youth offending teams and probation services, Jobcentre plus, accident and emergency services provided in a hospital, urgent treatment centres, in-patient hospitals, social service authorities, Ministry of Defence for members of the regular armed forces) which referred someone they thought might be homeless or may be threatened with homelessness to you over this period? Could you please give me the description of, and figures for the three most common types of reasons, as stated in the referrals, why those referred found themselves in that position of homelessness or at risk of homelessness (for example: debt problems, problems with a landlord, being a victim of domestic abuse, or other forms of violence/threats or intimidation, approaching discharge from hospital/armed forces or release from custody with no accommodation available to them, having previously been in care/ the armed forces or in prison). How many applicants, who were referred to you from organisations which believed they might be homeless or threatened with homelessness, were found to be eligible for assistance? Could you please give me the description of, and figures for the three most allocated types of accommodation (for example: (but not limited to) hotel, B&B, hostel, self contained accommodation) these eligible applicants were subsequently offered in their personalised housing plan?

The total number of referrals under the duty to refer (pursuant HRA 2017) between the 7 months period were 30 cases:

28 cases about 93% percent were contacted and their homelessness where assessed

About 7% no contact made.

2 were found not to be eligible for housing assistance

9 were asked to leave by relative and friends

6 was due to threat of domestic violence or violence.

5 due to hospital discharge

4 Prison discharge

2 evicted by licensor unable to pay rent.

7 of the above were found to be vulnerable or in priority need and were placed in temporary accommodation (2 in self-contained 5 in hostel sharing facilities)

21 of the above were found not to be in priority need, 11, were successful referred and privately rented accommodation. 6 received Part 6 offer of accommodation, 4 were accommodated by relative and friends. .

All 28 applicants were fully assessed and carried out Personalised Housing Plan except one who was found not to be eligible for housing assistance and who was referred to Social services for assistance.
